5. Proof of \$100,000.00 (minimum) liability insurance must be  
available at boat inspection or attached to application.
6. Headquarter waters for Choptank Nanticoke & Pocomoke only: **Off Limits.**  
12:01AM Saturday the day before Tournament. **All others No Off Limits**
7. Each team is allowed one substitute partner during the year. (Not the Classic)
